COMPETITION TERMS

Terms and Conditions

Your entry into the Queenstown Honey Testing Competition ("**Competition**") is deemed acceptance of these Terms.

Prize To Be Won

1. Enter the Competition to be in the chance to win a trip for 2 people to Queenstown, New Zealand.
2. The Prize includes:
 - (a) Return flights to Queenstown for 2 people (departing from Auckland, Christchurch or Wellington);
 - (b) 3 nights accommodation for 2 people at a hotel in Queenstown;
 - (c) Gondola ride for 2 people at Skyline Queenstown; and
 - (d) Premium Dinner for 2 at Skyline Queenstown's Stratosphere Restaurant and Bar to the value of \$230 ("**Prize**").
3. The total value of the Prize will not exceed \$2,000.

Promoter

4. The promoter of the Competition is R J Hill Laboratories Limited ("**Hill Laboratories**"). Promotion Period

5. The Competition is open for entry from **6am on Monday 1 April 2019** until **11:59pm on 30 June 2019** ("**Promotion Period**").

How to Enter

6. To enter the Competition, you must during the Promotion Period:
 - (a) Spend \$200 or more on any honey test service offered by Hill Laboratories;
 - (b) Write "Queenstown" in the 'Client Reference' of your Honey Testing Request Form; and
 - (c) Submit your completed Honey Testing Request Form to the address on the Form ("**Entry**").
7. Submission of your Entry may incur standard postage or courier fees to be paid by you.
8. You may only make one entry per person.

Selection of Winner

9. The winner of the Competition will be drawn on **3rd July 2019 at 3pm**. ("**Winner**").
10. The Winner of the Competition will be selected by Hill Laboratories making a random draw from among all valid and qualifying Entries.
11. If you are the Winner, Hill Laboratories will make reasonable efforts to contact you within 5 days of the draw using the contact details you supplied in your Entry. If for any reason Hill Laboratories is unable to contact you within that period, then you will be deemed to have forfeited the Prize and another winner will be randomly drawn in your place.
12. Hill Laboratories' selection of the Winner is final and binding.

Eligibility to Enter

13. To be eligible to enter the Competition you must:
 - (d) Be a New Zealand resident during the Promotion Period;
 - (e) Be 18 years or older; and
 - (f) Comply with these Terms.
14. Employees and contractors of Hill Laboratories during the Promotion Period are not eligible to enter the Competition.

Prize

17. The return flights to Queenstown, accommodation, gondola ride and dinner at Skyline Queenstown must all be taken before 31 December 2019 ("**Travel Date**").

18. The flight to Queenstown will only be departing from Auckland, Wellington or Christchurch. The return flight will be to the same city of departure. Both persons must depart from and return to the same city.
19. Accommodation and flight service provider will be selected by Hill Laboratories at its sole discretion.
20. The Winner must advise Hill Laboratories of their preferred travel dates and departure details at least one month before intended date of travel.
21. Airport transfers, additional meals, drinks and other incidental travel and accommodation expenses are not included in the Prize will be at the Winner's cost and responsibility to arrange.
22. All costs and expenses relating to any change to any part of the Prize once booked or confirmed with Hill Laboratories (for example including, but not limited to, changing flight dates, city of departure or upgrading of accommodation) will be at the Winner's cost and sole responsibility to arrange.

If you don't provide the requested personal information then your Entry might be invalid. You have the right to access and request correction of your personal information held by Hill Laboratories by contacting Hill Laboratories.

General Terms

29. Hill Laboratories' decision in relation to any aspect of the Competition is final and binding on you and no correspondence will be entered into.
30. Subject to any applicable laws which cannot be excluded, the Hill Laboratories, its employees and agents will not be liable for any loss, damage or injury of any nature incurred or suffered by you (including but not limited to direct or consequential loss or loss due to negligence) arising directly or indirectly out of or in connection with:
 - (a) your Entry into the Competition; or
 - (b) you winning, redeeming, benefiting from or using the Prize or any part of the Prize.
31. You agree that Hill Laboratories has the right to verify the eligibility and validity of all Entries, and the right to disqualify anyone for tampering with the entry process or for submitting an Entry not in accordance with these Terms.
32. Late, lost, stolen, misdirected, illegal, incomplete, illegible, damaged, reproduced, or altered Entries will be excluded from the Competition. Hill Laboratories will not responsible for any excluded Entries. If for any reason any aspect of the Competition is not capable of being run as planned, including any cause beyond the control of Hill Laboratories, Hill Laboratories may in its sole discretion cancel, terminate, modify or suspend the Competition, or invalidate any affected Entries.
