MYSTERY WEEKEND HONEY TESTING COMPETITION COMPETITION TERMS

Terms and Conditions

Your entry into the Mystery Weekend Honey Testing Competition ("Competition") is deemed acceptance of these Terms.

Prize ("Prize") To Be Won

- 1. Enter the Competition to be in the chance to win a Air New Zealand Luxury Mystery Break for 2 people, for two nights.
- 2. The Prize includes:
 - (a) Return seat+bag flights with Air New Zealand for two people
 - (b) Luxury 5 star accommodation for two nights
 - (c) Daily breakfast and dinner
 - (d) Avis rental car for the full duration of your stay
 - (e) Car park at accommodation provided
- 3. The total value of the Prize will not exceed \$3,800.

Promoter

Promotion Period

5. The Competition is open for entry from 8:00 am on 1st May 2024 until 12:00 am on 30th June 2024 ("Promotion Period").

How to Enter

- 6. To enter the Competition, you must during the Promotion Period:
 - (a) Test your honey with Hill Labs (any routine honey testing service offered by Hill Labs);
 - (b) Write "Mystery" in the 'Client Reference' of your Honey Testing Request Form; and
 - (c) Submit your completed Honey Testing Request Form to the address on the Form ("Entry").
- 7. Submission of your Entry may incur standard postage or courier fees to be paid by you.
- 8. You may only make one entry per person.
- Existing clients that submit honey testing jobs during the months of May and June will be automatically entered.

Selection of Winner

- 10. The winner of the Competition will be drawn on 1st July 2024 at 3pm. ("Winner").
- 11. The Winner of the Competition will be selected by Hill Labs making a random draw from among all valid and qualifying Entries.
- 12. If you are the Winner, Hill Labs will make reasonable efforts to contact you within 5 days of the draw using the contact details you supplied in your Entry. If for any reason Hill Labs is unable to contact you within that period, then you will be deemed to have forfeited the Prize and another winner will be randomly drawn in your place.
- 13. Hill Labs' selection of the Winner is final and binding.

Eligibility to Enter

- 14. To be eligible to enter the Competition you must:
 - (d) Be a New Zealand resident during the Promotion Period;
 - (e) Be 18 years or older; and
 - (f) Comply with these Terms.
- 15. Employees and contractors of Hill Labs during the Promotion Period are not eligible to enter the Competition.

Prize

- 16. There is only one Prize to be won.
- 17. The Prize is only valid for two people.
- 18. The Mystery Weekend must be taken before 31 December 2024 ("Travel Date").

- 19. The Winner must advise Hill Labs of their preferred travel dates and departure details at least one month before the intended date of travel.
- 20. Airport transfers, additional meals, drinks and other incidental travel and accommodation expenses not included in the Prize will be at the Winner's cost and responsibility to arrange.
- 21. All costs and expenses relating to any change to any part of the Prize once booked or confirmed with Hill Labs (for example including, but not limited to, changing flight dates, city of departure or upgrading of accommodation) will be at the Winner's cost and sole responsibility to arrange.
- 22. It is the Winner's sole responsibility to obtain, and procure that the person whom the Winner will be traveling with obtains, adequate and valid travel insurance.
- 23. If any reason the Prize or any part of the Prize is no longer available, then Hill Labs may (at its sole discretion):
 - (a) substitute the Prize or any part of the Prize for an equivalent arrangement; or
 - (b) make any changes to the Prize or any part of the Prize.
- 24. Hill Labs will not be liable to the Winner for any compensation if for any reason the Winner:
 - (a) cannot use the Prize or any part of the Prize as a result of clause 13; or
 - (b) cannot use the Prize or any part of the Prize before the Travel Date.
- 25. The Prize is not transferable and cannot be redeemed for cash. However the Prize can be exchanged for one \$3,500 Air New Zealand Mystery Break voucher or \$3,500 incl. GST testing credit with Hill Labs.

Publicity

26. The Winner agrees that Hill Labs may use his or her name and the information in his or her completed Entry for Hill Laboratories publicity purposes without any liability to pay compensation.

In accordance with the Privacy Act 2020, Hill Labs will collect and hold personal information (as defined in the Privacy Act) about you to conduct the Competition, keep you updated on the Competition, and send you marketing information on Hill Labs' latest testing services, and you consent to the use of your personal information for those purposes. If you don't provide the requested personal information then your Entry might be invalid. You have the right to access and request correction of your personal information held by Hill Labs by contacting Hill Labs.

General Terms

- 28. Hill Labs' decision in relation to any aspect of the Competition is final and binding on you and no correspondence will be entered into.
- 29. Subject to any applicable laws which cannot be excluded, Hill Labs, its employees and agents will not be liable for any loss, damage or injury of any nature incurred or suffered by you (including but not limited to direct or consequential loss or loss due to negligence) arising directly or indirectly out of or in connection with:
 - (a) your Entry into the Competition; or
 - b) you winning, redeeming, benefiting from or using the Prize or any part of the Prize.
- 30. You agree that Hill Labs has the right to verify the eligibility and validity of all Entries, and the right to disqualify anyone for tampering with the entry process or for submitting an Entry not in accordance with these Terms.
- 31. Late, lost, stolen, misdirected, illegal, incomplete, illegible, damaged, reproduced, or altered Entries will be excluded from the Competition. Hill Labs will not be responsible for any excluded Entries. If for any reason any aspect of the Competition is not capable of being run as planned, including any cause beyond the control of Hill Labs, Hill Labs may in its sole discretion cancel, terminate, modify or suspend the Competition, or invalidate any affected Entries.
- 32. If the testing required for entry is cancelled after submission or not paid for in full, then Hill Labs may (at its sole discretion), cancel the prize and another winner will be randomly redrawn.
